

According to Pcmag.com, eLearningindustry.com, Suny.edu most recent LMS report(s) (Fall 2018), 87 % of institutions and 91 % of student enrollments rely upon either Blackboard, Canvas, Moodle, or D2L . COCC LMS Review Team researched:

Blackboard accounts for 28 % institutions / 37 % of enrollments Canvas accounts for 21% institutions / 27 % enrollments. Moodle accounts for 20 % institutions /12 % enrollments, which suggests that it's most popular with smaller institutions. D2L 13 % of institutions , 15% of enrollments.

Recommendation: Request LMS vendors to visit campuses, provide information regarding the merits of their systems.

After presentations - suggest campus wide evaluation survey. Compile campus-wide responses to other LM systems. Provide estimates for change costs, and a go/no-go on RFP recommendation

Learning Management System (LMS) Review Update

Introduction: The office of eLearning and Academic Technology in partnership with Academic Affairs created a task force that lead an LMS Review in the spring of 2019. The purpose of that review was to analyze different LMSs to determine how well Blackboard is meeting our needs and to examine other LMSs to determine which best fits the needs of COCC.

After a comprehensive review and testing of the top four choices, a recommendation to Academic Affairs to allow the top LMS vendors to visit the Bend campus in the winter or spring of 2020. These LMS vendors will provide presentations to the campuses, (including Northern Campuses via Zoom) and a campus-wide survey will follow to rate the systems.

After the presentations and all surveys are complied, the final data from the campus-wide surveys, along with the previous finding from the LMS review team will be given to Academic Affairs. The task force will also provide an initial estimate of the resources required to make any changes, including estimated funding costs and training requirements.

If a move is made to another LMS, eLearning and Academic Technology will require time for our campuses to run two LMSs simultaneously for at least six months, in order to make a smooth transition, with training and infrastructure changes to a new mobile friendly online environment.

We believe that given the changes in LMS options and the growing need for flexible, reliable new technologies now is the best time for the department of eLearning and Academic Technology to lead a transparent and inclusive process whereby all stakeholder groups have opportunity to contribute to the analysis of whether or not to shift to a new LMS.

Alignment:
