New Business

- A. Request Medical Assisting (MA) program fee increase, 1st Reading Shannon Waller
 - MA currently has a program fee of \$150/term to cover materials and supplies
 - Recently calculated how much is actually being spent and due to increased costs in the medical field for supplies more than \$150/student is being spent
 - Request increasing program fee to \$200/term per student
 - Fee would apply to MA 111, MA 120 and MA 137

Motion to approve at 1st reading the proposal to increase the MA program fees with no suggested edits.

- B. Proposal for Allied Health/Cengage Course Fee changes, 1st reading Shannon Waller
 - Last year requested that AH 112 have a fee of \$60 to cover Cengage Inclusive Access for one class/term
 - Discovered that HIM students are the only ones that require AH 112
 - Students in the HIM program have a fee of \$179 for Cengage Unlimited attached to HIM 103 and are being double charged for Cengage products
 - Request removing the \$60 fee if a student outside of the HIM program takes the course they
 will need to buy the Cengage Access on their own

Motion to approve at 1st reading the Allied Health/Cengage Course Fees proposal with no suggested edits.
